Contingent Fee Audit Arrangements Issue State and local jurisdictions have supplemented their audit activities by engaging independent third-party tax auditors.¹ In some cases, the third-party auditors are paid via contingent fee arrangements (i.e., a fee in exchange for a percentage of the increased taxes, fees, or other amounts collected).
